"Community All-Stars" 2024 Scholarship Contest
Official Contest Rules & Submission Agreement

- **1. NOT AN INDUCEMENT TO INSURE:** Contest entrant ("Entrant" or "You") is advised and understands and agrees that the contest is not an inducement to insure, a premium rebate or a policy fee and does not provide any special favor, advantage, or any other benefit or consideration to the Entrant with regard to any current or future Independent Health insurance policy.
- **2. ELIGIBILITY:** No purchase is necessary to enter. YOU MUST BE A HIGH SCHOOL SENIOR TO BE ELIGIBLE TO WIN.] This offer is only open to individuals who reside in one of the following counties in New York State: Erie, Niagara, Chautauqua, Cattaraugus, Orleans, Genesee, Wyoming and Allegany. This offer is open to individuals who voluntarily choose to share a story with us. This contest is void outside of these eight counties. Employees of Independent Health Association, Inc., its affiliates, subsidiaries, related corporate entities, contractors, advertising and promotion agencies and suppliers of promotional materials (collectively "Independent Health"), immediate family members and members of the same household of Independent Health employees are not eligible to enter. - **4. HOW TO ENTER**: Only one entry per qualified student is permitted per category (Community All-Star, Wellness All-Star and Diversity & Inclusion All-Star). Essay entries submitted by qualified students must be a minimum of 350 words to be considered for the scholarship opportunity. Anyone who meets the eligibility requirements set forth above (see #2) can enter by:
- (1) Visiting.bizjournals.com/buffalo and following the appropriate links to arrive at the page containing the official electronic entry form. Enter the contest by filling out an official "Wellness All-Stars" Scholarship contest entry form and submitting it online by 9:00 a.m. (Eastern Time) on January 5, 2024 through March 8, 2024.
- (2) Send a letter via U.S. Mail containing the Entrant's name, address and telephone numbers (day and nighttime), name of high school, scholarship category and essay, to Independent Health at the following address:

All electronic entries MUST BE RECEIVED ON THE BUSINESS FIRST WEBSITE NO LATER THAN 5 PM (Eastern Time) ON March 5, 2024. All mailed entries MUST BE RECEIVED AT THE ADDRESS LISTED ABOVE NO LATER THAN 5 PM (Eastern Time) ON March 8, 2024.

Independent Health is not responsible for contest entries that (1) are submitted online but which are not fully transmitted to Independent Health by the stated deadline date for any reason, including but not limited to technical difficulties; (2) are submitted via United States Mail and are not received at the above address by the stated deadline date; (3) are illegible or (4) contain incomplete, false or incorrect information.

- **5. PRIZE:** There will be three (3) scholarships awarded for the chosen students with an approximate total retail value of two thousand five hundred dollars (\$2,500.00) per student. Total value of all prizes is seven thousand five hundred dollars (\$7,500.00).
- **6. WINNER SELECTION:** The scholarship winners will be chosen from all eligible entries by March 28, 2024. The scholarship winners will be chosen based on the submission story which is reviewed by an Independent Health panel. If a story is selected as the winner and is found to contain incomplete, false, incorrect or illegible information, it will be deemed ineligible and a new entry will be selected as the winner in its place. Determinations regarding such information shall be at the sole discretion of Independent Health, such discretion to be exercised reasonably. All determinations made by Independent Health are final.
- **7. WINNER NOTIFICATION:** The scholarship winners will be notified by letter within five business days of the panel review at the contact information he or she supplied on the contest entry form. The winner's name and school will be posted on the Independent Health website, independenthealth.com, as well as Business First's website, bizjournals.com/buffalo/ and by entering to win the Entrant grants Independent Health the right to put his or her name on its website and for advertising and promotional purposes without any compensation to Entrant.
- **8. WINNER CLAIMING A PRIZE:** The winners must claim his or her prize within thirty days from the latter of the date the mail notice is sent.
