### Who can join?

To join **Independent Health's Encompass 65 Basic (HMO)**, you must be entitled to Medicare Part A, be enrolled in Medicare Part B, and you must live in our service area. Our service area includes these counties in New York: Allegany, Cattaraugus, Chautauqua, Erie, Genesee, Niagara, Orleans and Wyoming.

### Which doctors, hospitals, and pharmacies can I use?

**Independent Health's Encompass 65 Basic (HMO)** has a network of doctors, hospitals, pharmacies, and other providers. If you use the providers that are not in our network, the plan may not pay for these services.

You must generally use network pharmacies to fill your prescriptions for covered Part D drugs.

Or, call us and we will send you a copy of the physician/provider and pharmacy directories.

### What do we cover?

Like all Medicare health plans, we cover everything that Original Medicare covers – and *more*. Some of the extra benefits are outlined in this booklet.

We cover Part D drugs. In addition, we cover Part B drugs including chemotherapy and some drugs administered by your provider.

### How will I determine my drug costs?

Our plan groups each medication into one of five "tiers." You will need to use your formulary to locate what tier your drug is on to determine how much it will cost you. The amount you pay depends on the drug's tier and what stage of the benefit you have reached. Later in this document we discuss the benefit stages that occur: Deductible, Initial Coverage, Coverage Gap and Catastrophic Coverage.

**MONTHLY PREMIUM, DEDUCTIBLE, AND LIMITS ON HOW MUCH YOU PAY FOR COVERED SERVICES**

<b>Monthly Plan Premium</b>	\$125 per month. In addition, you must keep paying your Medicare Part B premiums.
<b>Deductible</b>	Medical Deductible: Not Applicable. Prescription Drug Deductible: \$150 for Tiers 3, 4 and 5.
<b>Maximum Out-of-Pocket Responsibility</b>	Your yearly limit(s) in this plan: <ul style="list-style-type: none"><li>• \$7,550 for services you receive from in-network providers.</li></ul> If you reach the limit on out-of-pocket costs, you keep getting covered hospital and medical services and we will pay the full cost for the rest of the year. Please note that you will still need to pay your monthly premiums and cost-sharing for your Part D prescription drugs.  Optical dispensing, non-Medicare covered dental, premiums, hearing aids, hearing aid evaluation, and Medicare Part D prescription drugs do NOT count towards the out-of-pocket maximum.

<b>Coverage Gap</b>	<p>The coverage gap begins after the total yearly drug cost (including what our plan has paid and what you have paid) reaches \$4,130.</p> <p>After you enter the coverage gap, you pay 25% of the plan's cost for covered brand name drugs and 25% of the plan's cost for covered generic drugs until your costs total \$6,550, which is the end of the coverage gap.</p> <p>Independent Health offers additional gap coverage for select insulins. During the Coverage Gap stage, your out-of-pocket costs for select injectable insulins will be \$35.</p>
<b>Catastrophic Amount</b>	<p>After your yearly out-of-pocket drug costs reach \$6,550, you pay the greater of:</p> <ul style="list-style-type: none"><li>• \$3.70 copay for generic (including brand drugs treated as generic) and a \$9.20 copayment for all other drugs, or</li><li>• 5% of the cost.</li></ul>
<b>Part D Senior Savings Program</b>	<p><b>Deductible Stage:</b></p> <p>There is no deductible for select insulins. You pay \$35 for select insulins.</p> <p><b>Initial Coverage Stage:</b></p> <p>You pay \$35 for select insulins.</p> <p><b>Coverage Gap Stage:</b></p> <p>Independent Health offers additional gap coverage for select insulins. During the Coverage Gap stage, your out-of-pocket costs for select insulins will be \$35 for select insulins.</p> <p>The Part D Senior Savings Model is a voluntary model that enables participating Part D enhanced plans to lower Medicare members' out-of-pocket costs for insulin to a maximum \$35 copay per thirty-day supply. This fixed cost share applies to all stages of coverage: the deductible stage (if applicable), the initial coverage stage, AND the coverage gap stage. Since this is a Part D program only self-injected insulin meets the criteria for a Part D covered drug and is eligible for the cost savings under the Senior Savings Model (insulin received through a pump or oral diabetic medication is not eligible). This benefit is built into the plan.</p> <p>This does not apply to people who are already getting LIS "Extra Help" for their Part D drugs.</p>

- Review the provider directory (or ask your doctor) to make sure the doctors you see now are in the network. If they are not listed, it means you will likely have to select a new doctor.
- Review the pharmacy directory to make sure the pharmacy you use for any prescription medicine is in the network. If the pharmacy is not listed, you will likely have to select a new pharmacy for your prescriptions.

## Understanding Important Rules

- In addition to your monthly plan premium, you must continue to pay your Medicare Part B premium. This premium is normally taken out of your Social Security check each month.
- Benefits, premiums and/or copayments/co-insurance may change on January 1, 2022.
- Except in emergency or urgent situations, we do not cover services by out-of-network providers (doctors who are not listed in the provider directory).
